Claim Settlement

- Closest National Weather Station (as identified by Underwriter)
- On-Site Independent Weather Observer (to be approved by Underwriter)
- WeatherWorks, Weather Command, Athenium Analytics, or similar (Third Party Doppler Radar Monitoring System)

If an approved independent weather observer not secured by the Assured, for purpose of claim verification, Spectrum will designate the closest approved recording station in the terms of the contract. Should the Assured require additional information regarding an observer, please contact Spectrum.

Coverage is subject to a completed application, deposit premium payment on or before ten days prior to the start date of the sales period, and acceptance/approval of Spectrum. Final premium is due, based on final sales, immediately following the last date of sales period. It is the responsibility of the insured to verify that the promotion complies with all local laws and regulations.
